INTRODUCTION7X-4Z

The Concrete Pumping Association of Australia's 'Improving Safety Performance for Concrete Pump Trucks' project has been awarded key funding through the National Heavy Vehicle Regulator's (NHVR) Heavy Vehicle Safety Initiative, supported by the Federal Government.

The project aims to deliver Safer Drivers, Safer Vehicles and Safer Road Use by addressing specific points that will ensure the project is aligned with stated road safety priorities of governments, the NHVR and is consistent with safe system principles.

These points aim to acquire more understanding and communication of risks associated with operating oversize concrete pumps on-road,

whilst developing appropriate performance standards and operating conditions for larger concrete pumps, improving driver awareness and behaviour to ensure concrete pumps are operated safely in all road conditions, understanding new technologies to improve road safety, reviewing existing Performance Based Standards (PBS) performance requirements and finally, conducting field safety to validate computer models and inform the development of better performance standards, guidelines for safe operation, appropriate operating conditions, and safety information to inform stakeholders about concrete pump road safety.
